Introduction

What information do we collect?

We collect information from you when you register on our site for our newsletter, register interest in becoming a Club Leader, and register as an attendee at one of our local Clubs. We may also ask you to complete surveys that Rebel Labs use for research purposes.

If you contact us, we may also keep a record of that correspondence.

What do we use the information for?

The information that we collect could be used in any of the following ways:

- to personalise your experience of using our site
- to improve our website
- to improve customer service
- to send newsletters or emails
- to administer a survey, contest or other site feature

Your information, whether public or private, will not be sold, exchanged, transferred or given to any other company for any reason other than for the purpose of delivering our service without your consent.

The email address you provide may be used to send you information and updates about your involvement with Rebel Makers, as well as occasional news, updates, and service information from Rebel Labs. You will find an option to unsubscribe at the bottom of each email.

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information on our site.

Do we use cookies?

Yes, to make your experience of our site smoother we use cookies and track your usage.

Google Analytics

Visitors to the Rebel Makers website who have javascript enabled are tracked using [Google Analytics](#).

Google Analytics collects the following types of information from users:

- Type of user agent (web browser) used, software manufacture and version number.
- Type of operating system
- Screen colors (color processing ability of the users screen)
- Javascript support
- Flash version
- Screen resolution
- Network location and IP address
 - Can include country, city, state, region, county, or any other geographic data.
 - Hostname
 - Bandwidth (internet connection speed)
- Time of visit
- Pages visited
- Time spent on each page of the website
- Referring site statistics
 - The website (URI) the user came through in order to arrive at this website (example: clicking on a hyperlink from Yahoo.com that took the user to this website)
 - Search engine query used (example: typing in a phrase into a search engine like Google, and clicking on a link from that search engine)

This data is only used to optimize our website for our visitors.

This data DOES NOT include any personalized identification information such as:

- Names
- Phone numbers
- Email addresses
- Mailing addresses
- Bank account numbers
- Credit card information

Legal jurisdiction

All personal information and details held on and processed by computers situated in the United Kingdom.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties, who assist us in operating our website, conducting our business or providing services to you, so long as those parties agree to keep this information confidential.

We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising or other uses.
